The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:07 PM on November 12, 2024 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. been working with Turnkey since that discussion, and they are confident that the program is secure. The amount of storage available through CityView would be 250 gigs. Currently, the Planning office is only using about 25 gigs. Shewchuk said he would have a contract for review before the next meeting.

9. John Wyvill: Cox Communications update

John Wyvill and Government Account Manager Nate Rhodes discussed services that are available to government municipalities and answered questions.

10. Sheriff Mike Robinson: Jail Revenue update

Sheriff Robinson stated that \$90,769 was collected in the month of October. Currently, to date revenue is \$374,218.

11. Interim appointment of Sheriff Mike Robinson as Washington County Emergency Manager and set the salary of the appointed position at \$26,000/ year. PA
