Susie Paulsen, Clerk of Dist Court: Discuss LB9, the consolidation of District and County Court Paulsen stated that the state of Nebraska is trying to consolidate District and County Court and if it should pass, the county would no longer have to fund salaries and benefits for Dist Court. However, the county would also lose incentive money, bond money, court costs, and local control. Paulsen went on to say that the state could also potentially force County and District Courts to be housed in the same office, which would require either moving or remodeling current offices. Paulsen said that NACO also opposes the proposed bill and asked the county board to write a letter stating their opposition when it comes up for consideration again in January.
- 10. Sheriff Mike Robinson: Jail Revenue update

Chairman Dethlefs gave an update on behalf of Sheriff Robinson and stated the July jail revenue was \$104,545.

11. Finance Committee: Budget discussion

Kruger stated that there have been no changes to the proposed budget since last meeting and with the county valuation up 107% and a bigger beginning balance over last year, the proposed levy would decrease by 16.29%.
