Clerk of the District Court Susie Paulsen stated that the proposed bill would give the state control of the District Court offices. The state would take over salary and benefits, but the county would still be responsible for space and operating expenses. This would include having the county provide space to accommodate both County and District Courts, space that does not currently exist. Paulsen went on to say that the county would lose quarterly reimbursements along with 10% bond fees, and court costs. Co Attorney Vander Schaaf also stated his opposition to the proposed bill.
