The Washington County Board of Supervisors of Washington County, Nebraska, met in regular session at 3:00 PM on September 24, 2024 in the Supervisor's meeting room at the Courthouse in Blair, Nebraska. Notice of the meeting was given in advance thereof by publication in the Pilot-Tribune. A copy of the proof of publication is on file in the office of the County Clerk. Notice of the meeting was given to the members and a copy of their acknowledgement of the receipt of notice and the agenda are on record at the office of the County Clerk. Availability of the agenda was communicated in the advance notice and in the notice of the members. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman Steve Dethlefs declared the meeting was in session and that the meeting is being recorded. Dethlefs made note that the Open Meetings Law is posted on the door and the west wall.

- 8. Jerod Reimer, District Coordinator for Congressman Adrian Smith: Legislation and district update Reimer gave a brief update on the Congressman's work including items for Ways & Means Committee and current issues.
- 9. Justin Novak, Papio-Missouri NRD: Washington County Water #2 Expansion Project presentation Novak stated that due to growth in the county over the last few years, one of the rural water pump stations is operating at capacity. To meet the demands, Papio-Missouri NRD and the City of Blair have discussed a proposed project that would reconfigure system boundaries to allow some areas in the south part of the county to be served by the City of Blair, expand the rural water system, and utilize the Hwy 75 water main. Novak said that Papio-Missouri NRD is not asking for anything from the county at this time but will look for coordination with the county and City of Ft Calhoun sometime in the future as it will help when they go out for grant funding.
- 10. Jenny Eriksen, Jeanette Hunt Blair Animal Shelter presentation Eriksen gave a presentation outlining what the shelter does in Washington County, including but not limited to animal intake numbers by location, boarding and shelter costs, and community engagement.
- 11. Attorney Dave Drew: Discuss Ft Calhoun Township regarding possible plans for Co Rd P51 & P40. D/PA Drew gave a summary of the current conditions and hazards on Co Rd 51 & P40 such as steep grades, sharp turns, and limited visibility. Brad Hike, TD2 Engineering, went over the proposed design plan and said that it was determined that constructing improvements to a 55 mph standard will be cost prohibited and will require the acquisition of right of way. The township is asking the county to adopt urban design standards so that there would be no need to request a relaxation. Hike went on to say that if urban standards are applied, the minimum design speed would be 35 mph. Kramer asked Hike to define the difference between urban and rural area design standards. Board members discussed it at length. There was no action requested by Ft Calhoun Township at that time.
